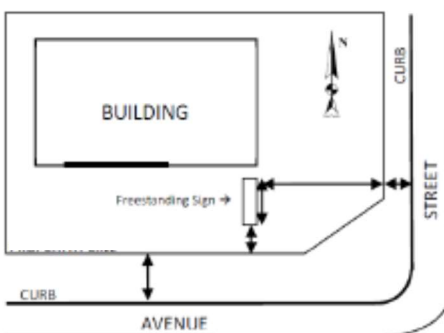

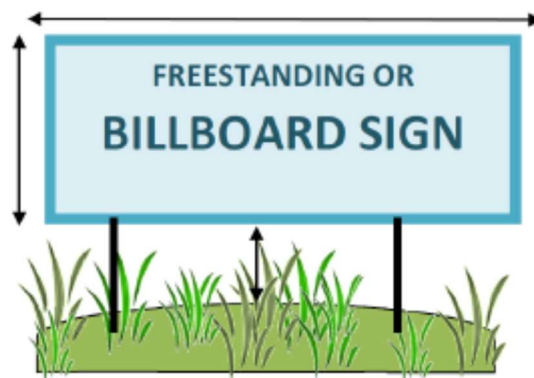
**SAMPLE SITE PLAN**
